Cookie Policy

1. What does this policy include?

Our website uses cookies. To find out more about what cookies are, how they are used on our website and how to manage them, please read this Cookie Policy carefully.

2. What are cookies? How does Meldafern use cookies?

Cookies are text files containing small amounts of information which are downloaded to your device when you visit a website. Software on your device, for example a web browser, stores the cookies and sends them back to a website next time you visit. Cookies allow websites to recognise your device and preferences, and provide information to the owners of sites which can be used to improve your online experience.

Cookies can be read by the website on a user's subsequent visits. The information stored in a cookie may relate to the user's browsing habits on the webpage, or a unique identification number so that the website can identify the user on his return visit.

Meldafern does not use cookies to collect any personal information. In fact, the only thing that cookies are directly used for is to tie the requests from a user's device to our web servers.

We may use third-party services which use cookies to track information about visitors' use of the website, including things like browser versions, operating system types, device types etc.

The information collected in this way enable us to understand the use of our website, including the number of visitors we have, the pages viewed per session, time exposed to particular pages, etc. This information helps us to provide visitors with a better experience and particular and relevant information.

We will not attempt to personally identify visitors from their IP addresses unless this is required for fraud identification or any other reason required by law.

Cookies do not in any way compromise the security of your computer.

3. What Types of Cookies Do We Use?

This section sets out information about the cookie technology that we use on our website.

We use following types of cookies on our website: necessary cookies; analytical cookies, performance cookies; functionality cookies; advertising cookies and others. Each cookie is described below.

Necessary

Necessary cookies are absolutely essential for the website to function properly. These cookies ensure basic functionalities and security features of the website, anonymously.

Functional cookies help to perform certain functionalities like sharing the content of the website on social media platforms, collect feedbacks, and other third-party features.

We will not enable any cookie by default except for those that fall under the "Necessary" category. The user will be asked via a pop-up window to select the cookie categories that they prefer to enable. A user's cookie preferences can be changed by the user at any time.
